On July 7, the Board of Trustees was forwarded an E-mail from a constituent, Mr Josef Strecker, inquiring about loud noises he has been hearing during the past couple of months. The e-mail was forwarded to all members of the Board as well as related department heads

In response, one of the trustees took it upon their self to refer the question to their spouse for reply. First of all, as a member of this board, I am far from being pleased to have any inquiry from anyone, especially a constituent, to be forwarded to any person other than an official of the Township for any reply This gives the impression that the answer is official and is the policy of this local government Furthermore, it sends a message that the elected officials have a lack of confidence in their department heads answering such questions properly. Last, it is in no way proper procedure

It is my opinion this type of action can not be tolerated and thereby. I resolved, we introduce an official policy that all statements in regards to the township government be through the board and/or department heads. NO EXCEPTIONS!
