Mr. Reuter stated the purpose of the emergency meeting was to address pending litigation. Mr. Reuter stated that Notification of Emergency Meeting was provided by fax and telephone to the press and parties who had requested notice, as required by law.

Mr. Reuter explained that late yesterday afternoon a lawsuit had been filed against the Township in Federal District Court, <u>Coalition Opposed to Additional Spending and Taxes and E. Alex Blum v. Colerain Township</u> The Plaintiffs are seeking injunctive relief against enforcement of certain provisions of the Zoning Resolution regulating signs.

Mr Reuter read resolution number 10-2006 entitled "RESOLUTION DECLARING MORATORIUM ON ENFORCEMENT OF CERTAIN PROVISIONS OF ZONING RESOLUTION RELATING TO SIGNS". Mr. Reuter asked if there were any questions from the Board There were none.
