Laurie Petrei, Communications Director for the Council on Aging, approached the Board. She provided an update on the Hamilton County Elderly Services Program. Ninety per cent of the program's funding comes from a senior services

In all, they have donated \$260,000 to community groups Because of the help from Mark Meyer to ensure a safe and successful ride, the Good Timers presented the Police Department with a \$2,500 donation. RITTER Mr Ritter said the central fueling station was discussed at the previous meeting He offered another path to consider: the Hamilton County sheriff's office has a large fueling station at their complex on Hamilton Ave. He said we could preserve some cash as this could be a temporary solution. We could put our construction on hold until the 3rd quarter of next year. Mr. Ritter said Col. Hofbauer said we would have cost savings over buying gasoline retail. Chief Meloy said that the savings are there and if they are willing to provide that

asset, he has no issue.

Chief Smith said the project is one we need to do. He doesn't see a problem with pushing it off, but would like to have a target date

Mr. Ritter said he saw this as an avenue to preserve a little cash.

Mr. Fiedeldey said it would be more convenient if it were here. There is the time component of going back and forth to Hamilton Ave. He said this might be a good time to go through the bid process; bids are now about as good as you're

going to get. It may be worthwhile to allow them to go forward and then decide to go ahead or pull back. Now is prime time to be buying.

Mr. Wolterman said the fueling station would have a valid return on investment. It is not proper to stall this process. Time is an issue and driving to refuel is a waste of time.

Mr. Ritter asked Chief Smith for an update on Rumpke. Chief Smith said his group has been in regular contact with Rumpke officials. The report is the same as a couple of weeks ago, with no increase in well temperatures. They will draw off gas from those wells which were shut down. EPA may require a trenching process to collect any excess gas.

#### MR. FIEDELDEY

Mr. Fiedeldey said that Tony Parrot from MSD approached the Board about a sewer line in the northern part of the township. Mr. Fiedeldey said that both Mr. Ritter and he had questions about this that went unanswered. Now, the Moody's report says that 30% of the township is undeveloped and the installation of the sewers in the northwestern part would add housing. Mr. Fiedeldey said the Comp plan is against sewers in this area, to keep rural character. We can't ignore what the comp plan says and the people who helped set the plan.

Mr. Wolterman said he wants to know who "they" is because others have asked him when the area will get sewers. He said that we have failing substations and the probability of pollution. We can still control the rural character but must be stewards of the environment.

Mr. Fiedeldey said that he is most upset that they didn't answer his questions. We deserve that respect.

Mr. Ritter said it's a common courtesy to respond. Mr. Foglesong will contact Mr. Parrot about responding.

# MR. WOLTERMAN

Mr. Wolterman said that Colerain Ave. traffic is getting more and more backed up. Traffic lights have gone out. We need to have ODOT work on the synchronization. There is more probability of accidents as the day light time gets shorter.

Mr. Wolterman asked about the hours of Halloween: Mr. Foglesong said trick-ortreat is October 31, 6-8PM.

Mr. Fiedeldey asked about the preemption system. Chief Smith says it's working very well from his perspective. Chief Meloy said most of his vehicles have this capability as well.

Mr. Ritter said he is going out of sequence, but would like to address the item about the property donation on W. Galbraith Road. Mr. Reuter said the property is at 3460 W. Galbraith, on north side of Galbraith. He said this would be a wonderful location for a park, and fill a significant need for recreation.

Mr. Reuter read Resolution 49-09, "Resolution Accepting Donation by Wert Family of Real Property Located at 3460 W. Galbraith Road for Park Purposes."

Colleen Smith of 10666 Gloria Ave. approached the Board about quality of life issues affecting her property. There is an outside generator behind her home, which is noisy and smells of gasoline. The neighbor has many dogs with feces built up. She said she has worked with Zoning and the Health Department.

Dr. Roschke has a call in to the Health Department. All three inspectors have been to the property. Mr. Wolterman said this is a rental property. Dr. Roschke said the owners received the notice of violation.

Chief Smith asked about the purpose of the generator as it must be wired properly. He suggested a joint inspection to see all the violations, if any. He said the joint inspection should be by the end of the week.
